Market Commentary – 4th Quarter 2019

The 4th quarter was a relatively positive one, with encouraging news coming from the macro environment and the monetary policy front.

USA and China agreed on a phase 1 trade deal that will be signed on January, after a long stalemate in 2019. The Federal Reserve also helped ease the Repo markets fears, adding liquidity to help the functioning of the money markets. On top of the above, the earnings growth for stocks in the previous quarter helped S&P 500 rise 8.5% and Eurostoxx 50 4.9%.

We remain flexible to our strategy and accommodative to any further developments that will come up in 2020
